

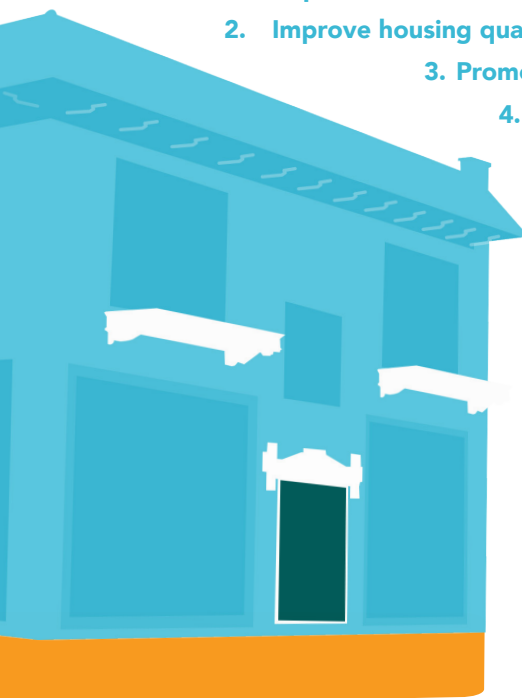

Introduction

Northwest Neighborhoods CDC is the nonprofit organization providing affordable housing and community development services for Cleveland's Cudell, Detroit Shoreway, and Edgewater neighborhoods. Our service area spans from West 45th to West 117th Street, north of I-90, and our community of nearly 28,000 residents is among the most racially, culturally, and socioeconomically diverse in Cleveland.

Northwest Neighborhoods is not your typical community development organization; central to our work is owning, managing, and protecting affordable housing in 15 properties for our most vulnerable residents.

We are thrilled to share some of the work we did in 2024 and the important services provided to our neighborhoods. While no report could truly summarize the work done or the successes achieved in our communities, this annual report highlights some of our accomplishments over the last year.

Last year, we introduced our new strategic plan, and since then we have worked towards achieving our eight strategic goals, each of which encompasses many types of projects. Some of our largest areas of focus this year were in continuing to move towards the groundbreaking of Karam Senior Living housing development, our new Eviction Diversion program, and strengthening our staff within our own organization

We could not do this work without our many communities. We are so proud of our work last year. We are looking forward to all that 2025 brings and the opportunity to continue to build a place where anyone can thrive.

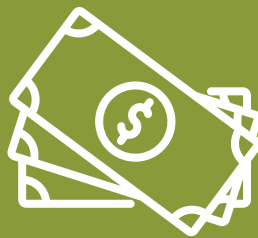

Karam Senior Living

In 2024, we celebrated the completion of fundraising for Karam Senior Living, which will add affordable senior housing to the new Cleveland Public Library (CPL) Walz Campus at West 80th Street and Detroit Avenue. We are prepared to begin construction in 2025, with an expected opening in 2026.

As a \$23 million investment, Karam Senior Living will counteract displacement pressures affecting vulnerable, older residents by providing 51 residential units to seniors who earn less than 30% and 50% of the area median income (AMI). Developed in partnership with CPL, the energy-efficient, accessible building will include a new Walz Campus for intergenerational connections and wrap-around programming. The development reimagines the northeast corner of West 80th and Detroit, adjacent to bus transit and healthcare providers, to more equitably serve the surrounding Detroit Shoreway and Cudell neighborhoods.

In addition to the voucher commitment by CMHA, key awards since 2020 have included \$2 million in ARPA Funds from Cuyahoga County, \$1 million in ARPA Transformative Neighborhood Project Funds from Cleveland City Council, \$2 million in ARPA Gap Funds from the City of Cleveland, and Low-Income Housing Tax Credits from the Ohio Housing Finance Agency.

Eviction Diversion

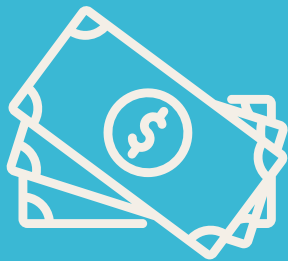
In early 2024, Northwest Neighborhoods embarked on an ambitious project to transform its property management approach. A key component was an eviction moratorium while building an in-house eviction diversion team and process. This process centers on preemptive interventions for tenants facing challenges, addressing issues before they escalate.

A critical part of this initiative is bridging organizational partnerships with other social service providers to offer coordinated care. By connecting these often isolated services, we're innovating the connectivity between providers and landlords. Our Wednesday working group collaborates to navigate challenges, leveraging resources and exploring non-eviction outcomes.

This wouldn't be possible without our dedicated and integrated staff teams, who have gone above and beyond to find solutions to complex problems. Their tireless work has been crucial in serving the community and supporting this emerging model.

Eviction is an incredibly harmful practice that destabilizes communities and incurs enormous costs. We hope to continually improve this model for the benefit of all Northwest Neighborhoods residents and to provide an equitable housing model for others to emulate.

Northwest Neighborhoods' Staff

In 2024, we launched a new integrated organizational structure, ensuring that all of our NWN staff are well-equipped and supported to best serve our neighborhoods..

In accordance with our strategic plan, it was important to the NWN leadership to invest in Northwest Neighborhoods' staff, internal operations, and systems so that Northwest Neighborhoods is effective, efficient, and an employer of choice.

This work in 2024 included redefining various staff roles, creating a new internal staffing structure, and providing new staff trainings. One of the largest transitions our teams dove into was combining the NWN property services team and neighborhood team, creating a more cohesive organization that is better prepared to engage in this complex work.

With the help of partner organizations, we were able to offer our staff Trauma-Informed Care and Fair Housing Trainings. We also empowered the members of our teams to seek out additional trainings and professional certifications to build their skills and career paths. Staff members participated in non-profit accounting courses, became certified in Advanced Mediation, participated in the Mandel Foundation's CDC Leadership Program, and more.

Part of our new staffing structures include the creation of new staff roles to lead our integrated teams and advocate for employee wellness and satisfaction. These roles help keep the big picture in focus, support staff to manage on-the-ground work, and ensure they have the tools needed to build capacity for success.

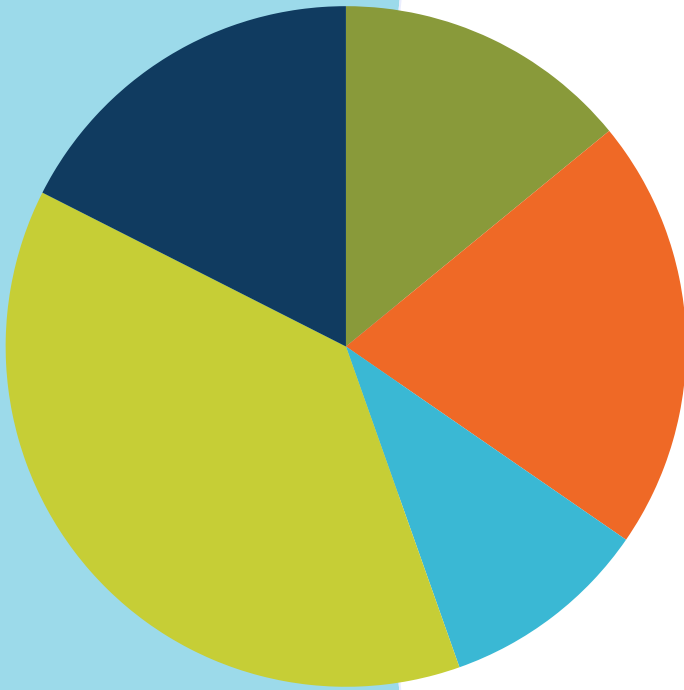

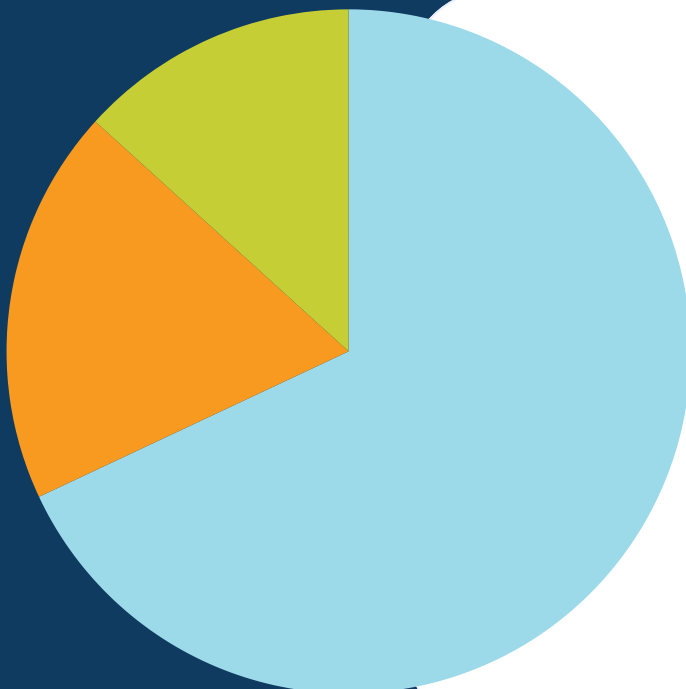
